GENERAL
HELL FIRE CLUB BUILDING TO BE CONSERVED AS RUIN, WITH MINIMAL INTERVENTIONS TO PROTECT THE STRUCTURE, REPLACE CERTAIN RECENT INSENSITIVE WORKS AND IMPROVE VISITOR SAFETY

FLOORING
DEBRIS TO BE REMOVED FROM EXISTING FLOORS. EXISTING STONE FLOORS, IF ANY, TO BE REPAIRED AS NECESSARY. IF STONE FLOORS ARE NOT REVEALED, NEW DURABLE STONE FLOOR FINISH TO BE LAID TO LATER DETAIL

STEPS
ADDITION OF ONE STEP TO THE EXISTING LARGE STEP DOWN TO "CARD ROOM" AT HALF LANDING.

HANDRAILS
REPLACEMENT OF IRON HANDRAILS TO STAIRS AND BALCONY (MODERN INTERVENTIONS BY COILLTE). NEW HANDRAILS TO BE REVERSIBLE INTERVENTIONS TO LATER DETAIL.

CHIMNEY FLUES
CHIMNEY FLUES TO BE GUARDED TO PREVENT ACCESS UP FLUES ONTO ROOF. SEALING TO BE REVERSIBLE.

GRAFFITI
ALL MODERN GRAFFITI TO BE REMOVED FROM WALLS. HISTORIC GRAFFITI TO BE RETAINED.

ROOF AND WALLS
REPAIRS TO ROOF AND WALLS TO PREVENT WATER INGRESS.

LIGHTING
DISCREET LIGHTING TO BE INSTALLED IN BUILDING AT POTENTIAL HAZARDS INCLUDING LEVEL CHANGES OR LOW LEVEL LINTELS & TO HIGHLIGHT SPECIFIC FEATURES.

CONSERVATION OF MEGALITHIC ART
SURVEY TO IDENTIFY ANY MEGALITHIC ART ON EXISTING MASONRY. MEASURES TO BE TAKEN TO ENSURE ANY ART IS UNOBSCURED BY RECENT OR PROPOSED INTERVENTIONS AND SUITABLY INTERPRETED.
